Message from the President

It is my pleasure to present the annual report for CBA Vision Rehabilitation Services (formerly Chautauqua Blind Association) for the year ending December 31, 2022.

CBA had a good deal accomplished over the past year. With Covid-19 and the Pandemic somewhat in the past, CBA resumed the annual Dining in the Dark fundraiser. Past sponsors, clients, and community members embraced CBA and joined together to support the youth vision screening program. It proved to be yet another successful event in CBA history.

CBA also established a strategic planning committee and worked with past board members and community members to come up with a much-needed strategic plan for the organization. As part of the plan, we designed a new logo, which is now displayed on a new sign outside of the office, as well as an updated website. The strategic plan focused on the organization's purpose and the importance of its services, and it was inspiring to see everyone come together and work hard for an organization that provides such a valuable service to the community.

Aside from the fundraiser that took place earlier in the year, CBA also held an online art auction titled "Art for Vision", which also supported the youth vision screening program.



Although the first online event of this nature posed a little bit of a challenge in executing, it proved to be another success in raising funds for the program.

In October, CBA held its first annual White Cane Awareness walk in Dunkirk, NY. Roughly forty community members, friends, and family of clients came together to show their support. The walk helped raise awareness of the white cane and dog guides who assist blind individuals.

Throughout the year, the organization demonstrated success and resilience, despite a change in staffing that resulted in having only one therapist on staff. Praise goes to the current staff, as they have maneuvered the change well and continue to provide crucial services to keep the organization going.

As we enter 2023, CBA will face upcoming changes. Our Executive Director, Joni Blackman, will be retiring at years end, and I sadly will end my 9-year term with the Board of Directors. I'm grateful to many individuals, foundations, organizations, and businesses who have showed support over the past year to the organization. It has been a pleasure to witness CBA succeed and provide valuable service to this community.

Message from the Executive Director

Dear Friends of CBA,

After being the Executive Director for a year and a month, I started 2022 with a feeling of excitement. With the Board of Directors' and staff's advice and assistance, I was ready to organize the much-needed strategic planning sessions to set CBA on the right track for the next 3–5 years. I was ready to start the fundraising and marketing work needed to have a successful fundraising year. And I was ready to refresh the marketing plan to raise awareness in our service region (Chautauqua and Cattaraugus Counties) to help more vision-impaired individuals.

Local leader Paul Fardink led the strategic planning sessions. The Board, staff, past clients, and local funders either met or completed surveys to gather their thoughts on CBA's place in the community. The plan evolved into a list of opportunities with goals, and action plans (with measurable outcomes) to implement the goals. A Board committee was formed to oversee the plan. You may have noticed the new logo which visually "says" CBA offers training to the legally blind. The name change to CBA Vision Rehabilitation Services actually happened years ago, but the full transition came with the new strategic plan. At this point, the plan has moved into implementing the opportunities and goals. They are having a greater presence in northern Chautauqua County and Cattaraugus County, building a network of volunteers and agencies to spread awareness of CBA's mission to serve the visually impaired, educate about vision health, and screen our youngest citizens. These actions are building both hands-on and financial support. The plan will be evaluated every year to correct course, if needed, to continue to develop and implement the opportunities.

2022's Dining in the Dark was a success. Over 160 supporters took part in the major fundraiser for the Youth Vision Screening program. \$12,000 was raised to support the ongoing costs of screening over 4,400 young children in our service area. Thank you to all the sponsors and guests, both new and returning, who continue to make this an annual commitment to the community.

The first "White Cane Safety Awareness Day Walk" was held in October. Over 40 supporters from the Dunkirk-Fredonia Lions Club, clients and their family members, Directors and staff gathered on a damp, chilly Saturday morning at the Dunkirk Memorial Park to learn about the history of the white cane law, our local connection to the law and its importance today. The crowd enjoyed pizza (thank you Pizza Village, and Tops for their donations). Eventually, the sun came out and we enjoyed meeting new friends and celebrating independence. Plans are underway to celebrate in Olean in October 2023.

I thank the Board of Directors for their work this year. The committees did the heavy lifting so the board meetings could be used to discuss concepts and ideas. The officers were dedicated to the work of CBA and assisted me throughout the year. I thank the staff for their dedication to our client's needs. CBA is a contract agency with the NYS Commission for the Blind. I am grateful for the Commission staff's advice, assistance, and support as we all navigate the uncertainty of a post-COVID 19 environment.

ADAPTIVE LIVING PROGRAM: 154 clients

This program is for individuals 55+ years old who are legally blind. They receive training in the following areas: personal care, communication skills, mobility indoor/outdoor & meal, home and financial management, and family care.



IMPACT

David

David is in the adaptive living program.

He suffered from sudden onset
blindness. While he depended on his
sister for many daily needs,
circumstances have changed and he
can no longer do so. David became
isolated. He had the courage to ask
CBA for help and is now learning to walk
outside with a cane and take care of his
daily needs.

VISION REHABILITATION: 80 clients

This program addresses the need for legally blind individuals to maintain current employment, obtain employment, attend college, or receive technology training – all to enable them to be prosperous and independent. Training is done at their home, school or workplace. Vision rehabilitation training and orientation and mobility instruction are both used in this program.



Karla

Karla moved to WNY from sunny Puerto Rico in 2022. What a shock it was to her system! She is young and ambitious. She did not receive adequate cane training or help with cooking and daily chores until she started working with CBA. Her goal is to attend college so she is learning English and working at Home Depot. She also has a dog guide to help her with her mobility.

INDEPENDENT LIVING: 7 clients

This program is for individuals who are legally blind, but are not employed..
They require less intense instruction to meet their goals.

Corbin is an elementary school student with a great sense of humor. He loves to cook with Debbie Liddell, CBA's VRT and O&M trainer. She is teaching him daily life skills he can use as his sight declines.

YOUTH VISION SCREENING PROGRAM: 4,425children screened at 103 locations 772 referred for professional services

This program provides FREE vision screening for our target population of 3–6–year–olds in public and private schools in Chautauqua and Cattaraugus Counties. Staff member Priscilla Shoup, Blindness Prevention Coordinator's goal is to identify young children who may have vision problems. When our screening indicates a child needs a comprehensive eye exam, a referral letter and application for financial assistance from the Dr. Tim Grace Sight for Success Program is sent home with the child.

IMPACT

ABIGAIL

As an infant, Abigail needed a pediatric ophthalmologist to manage her eye health. The doctor's office reached out to CBA to help her family obtain the needed exams and glasses. We have helped all along the way as she has grown into a bright, happy toddler!







Sight for Success Program

In 2022 the Dr. Tim Grace Sight for Success Program received 47 applications for exams and/or glasses. 28 of those children received glasses. The families that were in need of financial assistance chose to use the fund. This fund is dependent on donations as is the vision screening program. It is solely funded by local grants and donations.

With great thanks and appreciation, the fund was named the Dr. Tim Grace Sight for Success Program in 2020 after the passing of Dr. Grace who so strongly believed in CBA's mission and that everyone deserved to see the best they can.
