### 127 Visually Impaired clients were provided services

### 26 Clients Served in Vocational Rehabilitation (VR) Program

The VR program under our NY State Comprehensive Services Contract consists of individuals needing services to maintain current employment, obtain employment, attend college, or receive technology training enabling them to be prosperous and independent. Services include an assessment in the area of: Vision Rehabilitation, Orientation & Mobility, and Social Casework. Training is provided in-home, at their job or school and continues until goals are met.

# 88 Clients Served in the Adaptive Living Program (ALP)

The ALP program is under our NY State Contract and assessments are made on individuals 55 years and older in the areas of:
Personal Care, Meal Management, Family Care, Communication Skills, Home Management, Indoor/Outdoor Mobility, and Financial Management.
Training is provided in-home and continues until goals outlined in their assessment are achieved independently.

**4,497** children vision screened in **101** locations in Chautauqua and Cattaraugus Counties



730 Children referred for professional services for eye exams and potential glasses

In 2024, CBA staff remained active by screening children in PreK through 1st grade, across Chautauqua and Cattaraugus County schools. CBA's Youth Vision Screening is an essential program that helps identify vision issues and the need for glasses among young children. This program depends on funding from United Way, fundraising events, and private grants to operate.

Of those screened, 17% were referred on for services with a local eye care professional. Thanks to the Youth Vision Screening Program and the Dr. Tim Grace Sight for Success Fund, these children can now experience the world more clearly and have a better chance at a successful future.



### **Sight for Success Program**



In 2019, the Dr. Tim Grace Sight for Success program was named in honor of the late Dr. Tim Grace. Dr. Grace was a local eyecare professional with a passion for quality eyecare and the community. This fund coincides with our Youth Vision Screening Program and helps assist local children financially, if in need, to help them to receive the proper eyecare and glasses after they are vision screened. Private donations and fundraising help keep the Sight for Success fund available. CBA thanks the Grace Family and private donors for being continued supporters of our program and the service that we provide to the community.

## Program Highlights and their Impact

## Vocational Rehabilitation (VR)

This program addresses the need for legally blind individuals to maintain current employment, obtain employment, attend college, receive technology training, and enable them to be prosperous and independent. Training is done at their home, school, or workplace. Training can consist of orientation & mobility, braille, and the use of adaptive equipment and devices.

LS has been training towards obtaining a work experience. Due to her vision projecting to decrease, she is currently learning braille with our therapist, Debbie, LS moved into a new home this past year, so training was focused alot on cooking skills in her new kitchen and she is using a CCTV to read everything from mail to her daily exercises, as you can see in the photo.

### Adaptive Living Program (ALP)

This program is for individuals 55+ years old who are legally blind. They receive training in personal care, communication skills, mobility indoor/outdoor, eating meals, home and financial management, and family care. The primary benefit of this program is to allow senior citizens who are experiencing vision loss to function more independently in daily activities.



### **Winnie**

Winnie is in our ALP program and in 2024, she was living in a Senior Living Community. With the help of CBA training, she has been using her talking label wand to label things such as her medications and food in her freezer and cupboard. The label wand is also good to use for instructions for her cooking. By knowing food products and instructions, she has been able to cook for herself.

## <u>Program Highlights and their Impact, cont.</u>

### **Independent Living**

This program is for individuals who are legally blind, but are not employed. The program is designed to help clients carry out day-to-day activities. These services are provided based on individual need and may include: orientation and mobility services, rehabilitation teaching, low vision services and devices, social casework and adaptive equipment. But often require less intense instruction to meet their goals.





#### Phil

Phil has received services through our Independent Living Program. He is newly married and recently moved into a new house. where he had to learn how to navigate the new environment, including using new kitchen appliances. Phil loves to cook and by marking his stove and microwave, he is able to remain independent and cook for his wife.

### What is Orientation & Mobility?

Orientation and Mobility, (O&M) refers to the set of skills a person who is visually impaired uses to move safely and purposefully through the environment; basically, the ability to get where you need to go. Clients learn skills to help with their independence, navigate stairs, crossing of streets and use of public transportation. Clients in any of our VR, ALP, and Independent Living programs can receive Orientation & Mobility training.



Rose is one of our clients in the VR program. She has worked with our therapist, Debbie, to maintain her independence, and remain active and confident within her environment, including her past workplaces. Here she is pictured with her new guide dog, Vintage, "Vinny", whom she will be receiving some further orientation & mobility training with.
